Scope of Work for Biological Review

Southwestern Power Administration (Southwestern) will require a biological assessment for State and Federally listed threatened or endangered species, raptors and migratory birds. The purpose of this review is to provide Southwestern with specific information to determine if its proposed action will affect listed species or critical habitat and to ensure compliance with requirements listed within NEPA and EO 13186 as it pertains to the proposed aerial saw side clearing application for Southwestern's transmission line right-of-ways. The proposed aerial saw side clearing project will include approximately 178.57 miles of transmission lines located in the following Counties in Oklahoma: Bryan, Coal, Haskell, Hughes, Johnston, McIntosh, Muskogee, Okmulgee, Okfuskee & Pontotoc (Ref: Index Map, and Table 1). The average width of Southwestern's transmission line right-of-way is approximately 100 feet.

Task 1. Initial Evaluation/Literature Review

The first step in performing this biological review is to determine if special status species may occur in the vicinity of the proposed project area. Special status species, for the purpose of this review, include Federally threatened or endangered species, State threatened or endangered species, Raptors and Migratory Birds. The following steps will be used to perform species occurrence determinations:

- Contact the local Fish and Wildlife Service (USFWS) office for information on the known or potential occurrence of Federally threatened or endangered species.
- Contact the Local State office for information on the known or potential occurrence of State-listed species.
- Perform an online search of the National Heritage Program to obtain a list of occurrences or sightings for the area.

Task 2. Critical Habitat/Literature Review

If it is determined that special status species may occur in the project area, biological literature will be reviewed to determine if critical habitat for these species are present in the project area. Often, special status species have highly specific habitat requirements. This task will be performed using the following steps:

- Review habitat information from the USFWS or Local state wildlife offices.
- Perform a literature search of published information regarding the species habitat requirements.
- Review topographic maps of the project area, if necessary.

Task 3. Site-specific Affects Evaluation

If critical habitat and /or special status species are known to occur or have the potential to occur in the project area, a site-specific evaluation will be made as to the affect the use of an aerial saw to side clear transmission line rights-of-way. The evaluation will include a: 1) no affect, or 2) may affect determination. All evaluations will include an explanation for the evaluation response. The "may affect" determination will be further characterized as 1) beneficial affect; 2) not likely to adversely affect; or 3) likely to adversely affect.

For those site-specific cases where a “may affect” determination is possible, the evaluation shall also include mitigating measures that could be used to mitigate concerns and alter the determination to a “no affect” determination.

Information Provided by Southwestern

Southwestern will provide the following materials to perform this review:

- Transmission line index map indicating which sections of the transmission lines right-of-way will be affected by the proposed aerial saw side clearing.
- GPS locations for the structures of the following transmission lines: Part of Line 3016 from Eufaula to Stigler, Line 3101, & line 3106.
- A table identifying each section of right-of way to be cleared in each of Southwestern’s areas.
- A listing of USGS Topo Maps each transmission line will traverse.
- Electronic copy of selected sections of USGS Topo Maps marking the location of each transmission line subject to the biological assessment.

After completion of above listed task a report should be submitted to Southwestern which will include the following:

- Special status species known or likely to occur in the area of Southwestern’s transmission lines will be summarized in a brief report.
- Designated or potential critical habitat for special status species likely to occur within, or in close proximity to, the area of Southwestern’s transmission lines will be summarized in a brief report.
- A site-specific effects evaluation report for the potential impact the project will have on listed species or designated critical habitat. The evaluation shall also include mitigation measures that could be used to mitigate reason for a “may affect” determination and alter the determination to a “no affect” determination.
- Under no circumstances is the consultant to initiate informal or formal consultation with USFWS on behalf of Southwestern. In addition the consultant will not seek concurrence from USFWS for any opinions or findings associated with this biological review.



52.212-3 -- Offeror Representations and Certifications -- Commercial Items.
